DRAWBACK ON DUTY-PAID MATERIAL USED IN THE MANUFACTURE OF ARTICLES WITHIN THE COMMONWEALTH.

THE following Gazette Notice is issued in accordance with the provisions of Customs Regulation No.

Drawback may be allowed in terms of the Customs Regulations on the undermentioned imported material used in the manufacture of articles within the Commonwealth, upon the exportation of such manufactured articles, and subject to the conditions specified hereunder:—

73. Valves used in the manufacture of sluicing plants.

Provided that in each case, before drawback be allowed, the Collector shall be absolutely satisfied that the drawback claimed is properly due, and if he thinks necessary may require the manufacture to take place under the supervision of an officer.
